## 2026 Valentine's Day Bazaar General Information

1. Moenkopi Legacy Inn & Suites is NOT responsible for theft, injuries, or damages.
2. **Booth fees are NON-REFUNDABLE.**
3. Booth spaces are available for pre-selection. **Space selections are final.**
4. Vendors are to keep area clean. Trash receptacles will be available.
5. Sharing of booth spaces is prohibited. Only the individual listed on the application is permitted to sell. One helper is allowed to assist each vendor at their booth. No children are allowed in a booth space due to safety and liability.
6. Payment for booth spaces are to be paid in full at the time of the application. MLI only accepts debit/credit card and money order payments. Please make money order payable to: Moenkopi Legacy Inn, P.O. Box 2260 Tuba City, AZ 86045.
7. Tables are provided for the conference room area ONLY. Only 6 ft tables are allowed at the event.
8. Vendors must provide their own dolly or wagon. Use of hotel luggage carts is **NOT** permitted.
9. Vendor parking is in the back parking lot of the hotel.
10. Food handler's card shall be present upon sales of food. All individuals selling food must have an updated food handler's card. All food must be pre-made, pre-packaged, and ready to sell. **NO COOKING** is allowed inside of the building. Crock-pots, roasters, and warmers of any kind are not allowed.
11. Wi-Fi will be provided at a cost of \$10.00, the day of the event. Card transaction only.
12. Vendors will be allowed to set up at 8:00 AM, one hour prior to the bazaar.
13. If you aren't set up by 10:00 AM without notice, you must forfeit your booth space.
